ORDER:-

With the constitution of Greater Hyderabad and with many growth-triggering initiatives being taken up in the city, city is attracting lot of investment from National & International agencies. The increase in economic activity is resulting in large inflow of people from various parts of state, country and abroad. The population projected for the year 2031 is 1.7 crores as against the present 0.85 crores thereby putting huge demand in terms of water requirements of the city.

- 2. Keeping in view all these it was decided to work on the water source augmentation from river Godavari and the decision was taken to appoint M/s WAPCOS as consultants to conduct the feasibility study of drawing water from river Godavari.
- 3. The feasibility report was presented to the Government on 13.3.2007 covering the following details.

- 6. The preparation of descript reject report by M/s WAPCOS, for Phase-I is completed and the tentative cost of the SDWSS Phase-I is arrived to Rs3,375 Crores, based on rates prevalent as per CSSR 2007-08 for the months of June-August'2007.
- 7. With regard to the allocation of water from Sripadasagar, Yellampally, the I & CAD Department have communicated the allocation of 30 TMC of water under Pranahita-Chevella Lift Irrigation Scheme vide Govt. Memo No 14491/Maj. Irr. VIII(I)/2006, I & CAD(PW)Department dated 16.4.2008.
- 8. The project for augmentation of water supply to Hyderabad Urban Agglomeration (HUA) from River Godavari has been cleared in the 6th SLSC on 31.1.2008, and the project is to be posed to Government of India for funding under JNNURM scheme/outright grant. The project implementation may take about 30 months, the budget required over a period of three years starting from 2008-09 as below:
